3. Eligibility Requirements

Eligibility Requirements:

s. 7.1(d) of the Káí Tailé Denesǫ́line Trust requires candidates for the position of Trustee to be:

1. be a Member of ACFN;
2. be a resident of Canada;
3. be at least 18 years old;
4. not been convicted of theft, fraud or a similar offence unless they received a pardon;
5. not have declared bankruptcy;
6. not behind or in default of money owed to the ACFN;
7. not to have been found “mentally incompetent” by a court; and
8. not standing for election for Chief or Council of the ACFN.

4. Documents Required

Candidates for all positions must provide the following documents by the deadline provided in the notice of nomination – **October 13, 2023**:

- A nomination and candidates acceptance form, as provided by the Electoral Officer
 - Candidates must be nominated by at least five (5) members of ACFN who will be at least 18 years old on Election Day.
 - Candidates must sign the candidates acceptance of nomination and statutory declaration in the nomination form, which affirms that they have
 1. not been convicted of theft, fraud or a similar offence unless they received a pardon;
 2. not have declared bankruptcy;
 3. not behind or in default of money owed to the ACFN;
 4. not to have been found “mentally incompetent” by a court; and
 5. not standing for election for Chief or Council of the ACFN.
- Headshot photograph of yourself, to be used on the paper ballots and on OneFeather’s website (digital voting platform)
- Copy of your identification – front and back

12. not to have been found “mentally incompetent” by a court; and
13. not standing for election for Chief or Council of the ACFN.
